MADURAI-625-002 . The Second party represented herein by its Managing Director.

WHEREAS

- The First Party, a Higher Education Institution offering undergraduate and post graduate programmers in the Polytechnic disciplines, and
- The Second Party, a private limited company engaged in the manufacturing of aluminium die casting and rubber products



C. Both parties recognize that mutual cooperation and collaboration will lead to more effective utilization of their respective resources and open avenues for enhanced learning, research, and industrial exposure

CLAUSE 1: COOPERATION

1.1 The First Party and the Second Party share common goals and interests, and agree to establish a collaborative partnership

1.2 Both parties will work together to effectively leverage their intellectual and operational strengths

1.3 Each party agrees to cooperate and execute relevant agreements as promptly and practically as possible, as may be necessary for the successful implementation of this MoU

CLAUSE 2: SCOPE OF THE MOU

2.1 Industrial Exposure & Training

The Second Party shall support the First Party by facilitating:

- Industrial visits for students and faculty
- Industrial Training
- Internship and Apprenticeship programmes

These initiatives aim to strengthen the students' practical skills, enhance their confidence, and ensure a seamless transition from academic to industrial environment.

2.2 Duration of Training: The Second Party will provide training opportunities with a duration ranging from a minimum of three months to a maximum of six months for internships/apprenticeships.

2.3 Guest Lectures: The Second Party will offer guest lecturers to the students of the First Party, covering current industry trends and providing insights into technological advancements. The Second Party will also ensure the availability of in-house facilities and compliance with safety protocols during such sessions.

2.4 Student Placement: The Second Party will facilitate the placement of students from the First Party, based on the company's requirements and the performance of the trainees.

2.5 Evaluation: Both parties will collaborate in evaluating student performance during training, with appropriate mechanisms developed to award academic credits where applicable

2.6 Stipend/Fellowship: The Second Party may provide stipends or fellowships to eligible students from the First Party, in accordance with the norms and guidelines prescribed by the Board of Apprenticeship Training (BOAT).

CLAUSE 3: VALIDITY

3.1 This MOU shall remain valid for a period of three (3) years from the effective date unless terminated earlier by either party through mutual consent and agreed-upon



CLAUSE 4: NATURE OF RELATIONSHIP

4.1 It is clearly understood that this MOU does not constitute a legal partnership or joint venture between the First Party and the Second Party. Both parties shall function as independent entities for all purposes under this agreement.


